# Coupon Policy

**Please present all coupons to the cashier at the beginning of your order. Cashier must review all coupons to ensure they comply with eligibility requirements and verify the products purchased correspond with the coupons presented.**

**Please be advised of the following:**

1. Items must meet purchase requirements or stipulations specified on the coupon by the manufacturer.
2. No orders may be separated for the purpose of exceeding daily and/or household coupon or sale item limitations.
3. King Kullen reserves the right to limit quantities in coupon usage, as well as products, and to amend our policies as we deem appropriate.

4. King Kullen Double Coupons are subject to the following limitations:

**A maximum of five [5] \$1.00 off coupons per household/per 24 hour period will be doubled.**

(Maximum of two of any identical coupons will be doubled.)

The first five [5] \$1.00 off coupons scanned will double and the remaining \$1.00 off coupons will be credited at face value. All coupons valued at .99 cents or less will be doubled according to the following guidelines:

- Items must meet Purchase Requirements specified on coupon.
- Maximum of 2 coupons will be doubled on any individual coupon per day, per household:  
For example, if you have 3 Ragu coupons only 2 will be doubled, one will not regardless of flavor or variety purchased. The third will be processed at face value.
- Does not apply to free coupons or any coupons marked "DO NOT DOUBLE".
- Does not apply to coupon in excess of \$1.00. • Does not apply to competitor's store coupons.
- Does not apply to King Kullen coupons. • No item substitutions.
- Does not apply to cigarettes, tax, beer or bottle deposit.
- The total may not exceed the price of the item. For example, if an item is priced at forty-five (.45) cents and a twenty-five (.25) cents coupon is presented, the item is free. No further discount will be given.

5. King Kullen is pleased to accept coupons obtained on the Internet, subject to the following guidelines:

- There is a limit of two [2] on any identical Internet coupon, per household, per day.  
Example: we will take no more than 2 Ragu 15 oz. coupons, but we will take 2 Ragu, 2 Mott's, and 2 Tropicana (etc.)
- Internet coupons for "free" product will not be accepted.
- King Kullen's provisions regarding Double Coupons (above) also apply to Internet coupons.
- Coupons must be printed legibly and be scannable.

6. We do not accept competitor's store coupons.

7. There may be no substitutions.

8. The total amount saved via the use of any coupon may not exceed the price of the item.

For example, if an item is priced at \$.45, and a \$.25 coupon is presented, the item will be free. No further discount will be given, and there is no "cash back" if the coupon or double coupon value exceeds the price of the item.
